1. The Churches Health Association of Zambia has provided for funds under the New Funding Module (NFM4)-GC7 Grant and intends to apply part of the funds to payments under the Contract for the supply and delivery of **Rapid Diagnostic Tests (RDTs)** for Malaria.

Bids must be delivered and deposited in the tender box located at the main reception, first floor of CHAZ House at the address below on or before **Thursday 11th December 2025** at 12:00 hours, Local Time. Late bids will be rejected. Bids will be opened in the presence of the bidders and/or their representatives who choose to attend in person at CHAZ Complex, Plot No. 2882/B/5/10 Mission Drive, Water Falls, Lusaka. A Bid Security (Bank Guarantee) of 2% (two percent) of the bid sum or an equivalent amount must accompany all bids in a freely convertible currency or a **Bid-Securing Declaration** (Declaration Form) which will take three (3) years suspension period if the Bid – Securing declaration is not complied with by the bidder withdrawing its bid.

The bidder **must** comply fully with the technical specifications set out in the bidding documents (**Technical Specifications section**) and conform in all respects with the drawings, quantities, models, samples, measurements and other instructions. Failure to do so will render a bidder to be non-responsive.
8. The Purchaser (CHAZ) reserves the right to accept or reject any bid, and to annul the bidding process and reject all bids at any time prior to contract award, without thereby incurring any liability to Bidders. The Purchaser (CHAZ) is under no obligation to accept the lowest bid.
