

## Invitation for Bids (IFB)

### **LSMFEZ/ONB/PR0131/2026: TENDER FOR THE CONSTRUCTION OF A 2KM NORTHERN BOUNDARY WALL FENCE AT LUSAKA SOUTH MULTI-FACILITY ECONOMIC ZONE**

1. Lusaka South Multi-Facility Economic Zone (LS-MFEZ) has set aside funds to meet the cost for the construction of a 2km boundary wall fence at LS-MFEZ and intends to apply part of the proceeds of this financing to payments under the agreement resulting from this IFB.
2. LS-MFEZ now invites sealed bids from eligible Citizen Bidders for the Construction of a 2km northern boundary wall fence at LS-MFEZ.
3. Bidding will be conducted using the Open National Bidding (ONB) procedures specified in the Public Procurement Act No.8 of 2020 and the Public Procurement Regulations of 2022 and is open to citizen bidders as defined in the Bidding Documents, that meet the qualification criteria indicated in the Standard Bidding Document.
