

## TENDER FOR THE PROVISION OF MEDIA COVERAGE FOR TAXPAYER SENSITIZATION PROGRAMS THROUGH A FRAMEWORK AGREEMENT FOR A CONTRACT PERIOD OF THREE (3) YEARS.

The Zambia Revenue Authority has set aside funds for the provision of media coverage for taxpayer sensitization programs through a framework agreement for a contract period of three (3) years and intends to apply part of the funds to cover eligible payments under the Contract for which this tender has been invited.

The Zambia Revenue Authority now invites sealed bids from reputable Radio Stations, Print Media and TV Stations for the provision of media coverage for taxpayer sensitization programs through a framework agreement for a contract period of three (3) years.

Bidding will be conducted through Open National Competitive Bidding (ONB) procedures consistent with section 39(2) of the Public Procurement Act (PPA) No. 8 of 2020 and as amended by the Public Procurement (Amendment) Act No.17 of 2023 including the Public Procurement Regulations Statutory Instrument No. 30 of 2022 under regulation 34 of the Laws of Zambia.
