Bidding will be conducted through the Open International Bidding procurement procedure specified in the Public Procurement Act of 2020 and the Public Procurement Regulations of 2022 and is open to citizen, local and foreign bidders as prescribed by the Public Procurement Act No. 8 of 2020, read together with the Public Procurement (amendment) Act No. 17 of 2023. **However, a foreign bidder shall be required to participate in the Open International Bidding with/without partnering with the Citizen Suppliers.**
