3. Tenders shall be quoted in **Zambian kwacha (ZMW)** and shall include **all applicable taxes and levies**.
4. Tenders shall remain valid for a period of **One Hundred and Twenty-Six (126) days** from the date of tender opening.
5. All tenders must be accompanied by a **Tender Security from bank** equivalent to **one percent (1%)** of the tender sum.

Tenders will be opened immediately thereafter in the presence of tenderers or their duly authorized representatives who choose to attend.
10. **Electronic tenders will not be permitted.**
11. **Late tenders shall be rejected.**
12. Tender evaluation and qualification criteria shall be in accordance with the requirements specified in the tender document and the **Public Procurement and Asset Disposal Act, 2015** and its attendant Regulations.
