The Electoral Commission of Zambia wishes to hire two thousand one hundred motor vehicles for the 2026 General Election countrywide.

The Electoral Commission of Zambia has made budgetary provisions towards the cost of procurement for the hire of two thousand one hundred motor vehicles for the 2026 General Election countrywide.

The Electoral Commission of Zambia now invites bids from interested eligible firms for the hire of the aforementioned motor vehicles.

Bidding will be conducted through Open National Bidding (ONB) procedures specified in the Public Procurement Act No. 8 of 2020 as amended by Act No. 17 of 2023 and the Public Procurement Regulations of 2022 and is restricted to **eligible citizen and local bidders**. The terms citizen and local bidder are defined in the Public Procurement Act No. 8 of 2020 as amended by Act No. 17 of 2023.

The bids must be deposited in the tender box on the Ground Floor, Reception, Electoral Commission of Zambia offices, Lusaka, at or before 14:00 hours local time on Friday, 26th June, 2026.

The closing date for the receipt of bids is 10:00 hours local time on Friday, 26th June, 2026, and any bids received after the time and date stipulated above will not be accepted.
